

ESSENTIAL REQUIREMENTS FOR HESLB HIGHER EDUCATION LOAN APPLICATION 2025/2026

1 TREGISTRATION INFORMATION

Required:

- Examination numbers (Form IV CSEE and Form VI ACSEE)
- Applicant's mobile phone number
- Applicant's email address
- Application fee: TZS 30,000/= for Degree, TZS 20,000/= for Diploma

Purpose:

- Verifying the applicant's identity and contacts
- Application fee supports processing costs

How to obtain:

- Payment is made through a Control Number issued in the HESLB OLAMS system
- Pay via mobile money or bank channels

2 BIRTH DETAILS

Required:

- Date of birth
- RITA verification number (from RITA birth certificate verification)
- NIDA (National ID) number (for applicants aged 18+)
- Death certificates of parent(s), if deceased
- Region and district of birth
- Passport photo with blue background

Purpose:

- Confirm age and eligibility
- For orphans, death certificates verify parental status

How to obtain:

- RITA code: <u>https://verifi.rita.go.tz</u> or visit a RITA office
- Death certificate: From RITA or local government offices
- NIDA number: Visit <u>https://nida.go.tz</u> or nearby NIDA offices

Timeframe:

- RITA code: 3–7 days
- NIDA: 1–3 weeks
- Death certificates: 1–7 days

3 DPERMANENT RESIDENCE INFORMATION (NAPA)

Required:

• P.O. Box, Region, District, Ward, Village/Street

- Postal code of your residence
- House number
- NAPA Reference Number

Purpose:

• Verifying permanent address of the applicant

How to obtain:

- Visit local government office (Mtaa/Kijiji)
- Request to be registered in the National Permanent Address (NaPA) system
- After registration, visit https://napa.mawasiliano.go.tz to request an introduction letter with a NAPA reference number

Timeframe:

• 1–3 days depending on registration readiness

4 PARENTS'/GUARDIANS' INFORMATION

Required:

- Full names, education level, occupation, phone, P.O. Box, postal code, NAPA Reference Number
- If parent/guardian has a disability: must attach official form signed and stamped by the District Medical Officer (DMO) or Regional Medical Officer (RMO) as per HESLB guidelines
- Parental status: alive/deceased (attach death certificate if deceased)
- TASAF status: if family benefits from the social support program, provide registration number

Purpose:

• Evaluate applicant's social and economic background

How to obtain:

- Information from family/guardian
- TASAF registration from village/street office or district council
- Death certificate from RITA
- Disability verification from public health facilities

Timeframe:

- TASAF ID: Immediate if already enrolled
- Death certificate: 3–7 days

5 DISABILITY INFORMATION (If applicable)

Required:

- Statement confirming disability
- Type of disability
- Medical certificate or letter from a recognized health facility

Purpose:

• Special consideration and priority in the loan application process

How to obtain:

- Official medical diagnosis from government or registered private hospitals
- Letter signed by DMO/RMO

Timeframe:

• 1–5 days depending on the hospital

6 DUCATION DETAILS

Required:

- Confirmation of Form VI graduation
- Diploma exam number (if applicable)
- AVN Number (Award Verification Number) from NACTVET
- Name of college and year of completion

Purpose:

• Verify educational qualifications

How to obtain:

- Use official transcripts or certificates
- AVN from https://www.nacte.go.tz

7 SPONSORSHIP DETAILS (If applicable)

Required:

- Sponsor's full name, phone number, P.O. Box
- Official sponsorship letter from a registered organization

Purpose:

• Confirms if the applicant is currently sponsored by any governmentrecognized institution

How to obtain:

• Collect official letter from sponsor

• HESLB will provide a sponsorship form in your OLAMS account

Note:

• Sponsor must be an official organization or institution

8 GUARANTOR DETAILS

Required:

- Full name, gender, region, district, ward, street, email
- National ID (NIDA), driving license, or passport
- NAPA Reference Number
- Passport size photo (blue background), postal code, house number

Purpose:

• A guarantor supports and confirms your information legally

How to obtain:

• Directly from your guarantor

9 BANK DETAILS

Required:

- Bank account name
- Bank account number
- Name of the bank

Purpose:

• Loan funds are disbursed directly into this account

Important:

• Bank account name must match the name on school certificates

S FOR DIPLOMA & CONTINUING STUDENTS

Diploma Applicants:

- AVN Number
- Ensure your course is listed in HESLB guidelines
- Mention institution and course offered

Continuing Students:

- Must have passed to proceed to next academic year
- Provide institution name, course, registration number, and current academic year

IMPORTANT:

Ensure all information is correct and verified before submission. Amendments to documents like birth certificates or NIDA details may take time. Start preparing early before the official application window opens.
